**PLEASE NOTE THESE REGISTRATION POLICIES:**

1. Children attending the religious education program should be registered members of this parish. Please complete a census form if your family is not registered. A short form is on the front page of the parish bulletin.
2. Students may receive their 1<sup>st</sup> Communion in the second grade. However, students must have attended religious education classes for **one full year** prior to enrollment for 1<sup>st</sup> Communion classes. No more than 4 absences.
3. Our High School Confirmation Program is for students in Grades 9 - 12. However, **students must have been involved in parish life for at least one year immediately preceding entry into the program.** Evidence of involvement includes attendance at weekly Mass **and** participation in religious education or youth ministry program for the year preceding entry into the Confirmation program. Students who have not yet received their 1<sup>st</sup> Communion will be prepared for that sacrament together with the sacrament of Confirmation.
4. Please attach a copy of your child's baptismal certificate if your child will be entering the 1<sup>st</sup> Communion or High School Confirmation Program.
5. The Diocese of Honolulu promulgated a policy on allegations and incidents of sexual misconduct. The Charter for the protection of children and youth is contained in the handbook, "*Promise to Protect, Pledge to Heal*" The Church endorses the mandatory reporting provisions of H.R.S. Chapter 350 concerning child abuse. All staff members and teachers/catechists are required to sign an acknowledgment that they have read and understood the ethical and personal conduct policies of the Diocese of Honolulu. Consistent with diocesan policy, Our Lady of Sorrows will conduct Safe Environment training as part of the religious education curriculum. A meeting will be held before the class is conducted to provide parents an opportunity to review the safe environment materials.
